**THE SHROPSHIRE COUNCIL (FOOTPATHS 73, 71 (PART) AND 75Y, PARISH OF
NEEN SAVAGE) PUBLIC PATH DIVERSION ORDER 2018**

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interest of the landowners of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the lines of the ways should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public rights of way over the land situated at Overwood Common and shown by bold continuous lines on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it those public rights of way.

2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely: Where immediately before the date on which the footpaths are diverted there is apparatus under, in, on, over, along or across them belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

3. There shall on the date of confirmation of this Order be public footpaths over the land situated at Overwood Common described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.

3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.

4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART I

Description of site of existing paths or ways

The full width of **Footpath 73** Neen Savage from point A on the Order Map (GR SO 6835 7931), running in a general southerly then south westerly direction along the access to and through the grounds of 'Little Overwood' for approximately 120 metres then crossing the boundary to the property and continuing generally south-south-westerly for approximately 25 metres following a field boundary and then turning generally west-south-westerly followed by south-south westerly direction for approximately 350 metres across an arable field to point B on the Order Map (GR SO 6807 7895); a total distance of approximately 495 metres.

The full width of that part of **Footpath 71** Neen Savage from point F on the Order Map (GR SO 6837 7914) running in a general east-south-easterly followed by south easterly direction across an arable field to point G on the order map (SO 6863 7900); a total distance of approximately 308 metres.

The full width of **Footpath 75Y** Neen Savage from point J on the order map (GR SO 6802 7876) at a junction with Footpath 74, running in a general south-south-easterly direction parallel to the County Road through a partially wooded area to meet the county road at point K on the order map (GR SO 6809 7863); a total distance of approximately 152 metres.

PART 2

Description of site of new paths or ways

Footpath 73 Neen Savage to be created from a field gate at point C on the Order Map (GR SO 6834 7931) at a junction with Footpath 66, running in a general southerly direction for approximately 125 metres on a natural surface adjacent to the access to 'Little Overwood', then across a paddock to follow a bund alongside a pond to point D on the Order Map (GR SO 6834 7919) at a pedestrian gate in the boundary giving access to an arable field. From here the route continues in a general south westerly direction across an arable field for approximately 360 metres

to point B on the Order Map (GR SO 6807 7895) at its junction with Footpaths 74 and 82; a total distance of approximately 485 metres with a width of 2 metres throughout.

That part of Footpath 71 Neen Savage to be created from point D on the Order Map (GR SO 6834 7919) running in a general east-south-easterly followed by east-north-easterly then east-south-easterly and then easterly direction following a field edge path on a natural surface with a width of 2 metres for approximately 485 metres to join a surfaced access track with a width of 3 metres which the path follows in a general southerly direction for approximately 115 metres to point E on the Order Map (GR SO 6877 7900); a total distance of approximately 600 metres.

Footpath 75Y Neen Savage to be created from point H on the Order Map (GR SO 6804 7894) at a junction with Footpath 74, running in a general south-south-easterly direction on a field edge path with a natural surface to meet the county road at point I on the order map (GR SO 6812 7865) via a pedestrian gate; a total distance of approximately 160 metres with a width of 2 metres throughout.

PART 4

Modification of Definitive Statement

Footpath 73 Neen Savage to be created from a field gate at point C on the Order Map (GR SO 6834 7931) at a junction with Footpath 66, running in a general southerly direction for approximately 125 metres on a natural surface adjacent to the access to 'Little Overwood', then across a paddock to follow a bund alongside a pond to point D on the Order Map (GR SO 6834 7919) at a pedestrian gate in the boundary giving access to an arable field. From here the route continues in a general south westerly direction across an arable field for approximately 360 metres to point B on the Order Map (GR SO 6807 7895) at its junction with Footpaths 74 and 82; a total distance of approximately 485 metres with a width of 2 metres throughout.

That part of Footpath 71 Neen Savage to be created from point D on the Order Map (GR SO 6834 7919) running in a general east-south-easterly followed by east-north-easterly then east-south-easterly and then easterly direction following a field edge path on a natural surface with a width of 2 metres for approximately 485 metres to join a surfaced access track with a width of 3 metres which the path follows in a general southerly direction for approximately 115 metres to point E on the Order Map (GR SO 6877 7900); a total distance of approximately 600 metres.

Footpath 75Y Neen Savage to be created from point H on the Order Map (GR SO 6804 7894) at a junction with Footpath 74, running in a general south-south-easterly direction on a field edge path with a natural surface to meet the county road at point I on the order map (GR SO 6812 7865) via a pedestrian gate; a total distance of approximately 160 metres with a width of 2 metres throughout.

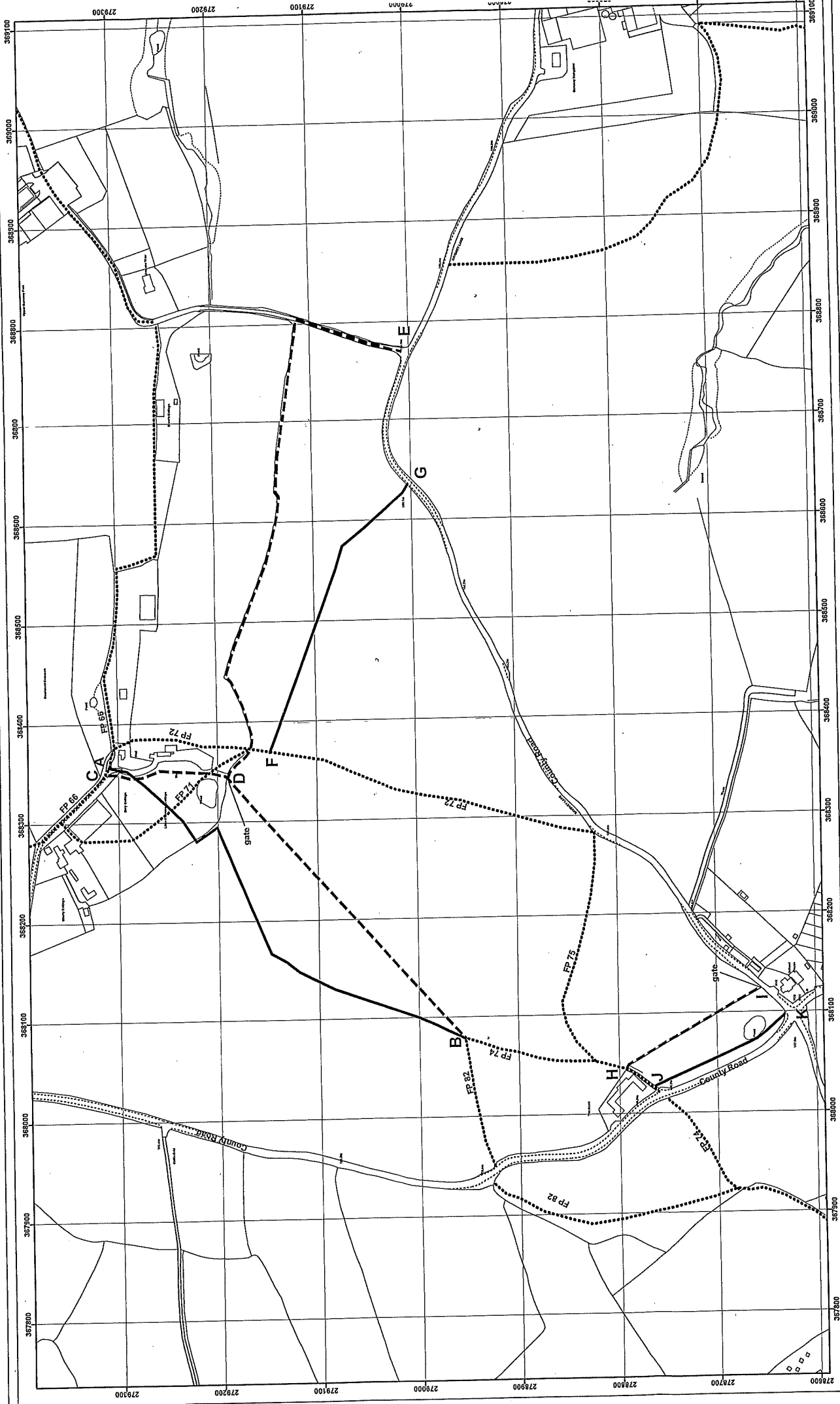
