



**PUBLIC PATH EXTINGUISHMENT AND  
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980  
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (FOOTPATHS 71 (PART), 72 AND 75, PARISH OF  
NEEN SAVAGE) PUBLIC PATH EXTINGUISHMENT ORDER 2018**

This order is made by The Shropshire Council ("the Council") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that the footpaths described in paragraph 1 below are not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of the event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

**BY THIS ORDER:**

1. The public rights of way over the land situate at Overwood Common in the Parish of Neen Savage shown by continuous bold lines on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it those public rights of way, and upon the occurrence of the extinguishment the Shropshire definitive map shall be modified by deleting from it those public rights of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.
2. Notwithstanding paragraph 1 of this order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:  
Where immediately before the date on which the footpaths are extinguished there is

apparatus under, in, on, over, along or across them belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

## **SCHEDULE**

### **PART 1**

#### **Description of Public Rights of Way Extinguished**

##### **Footpath 71 (Part), Neen Savage**

The full width of that part of Footpath 71 Neen Savage, from point A on the Order Map (GR SO 6829 7935) at Cherry Cottage, running in a general south-south-westerly direction on a gravelled path to pass through a gate and continue across a paddock in a general southerly direction to a second gate into a further paddock continuing in a general south easterly direction passing a pond to cross a stile into an area of rough ground and continuing to point B on the Order Map (GR SO 6837 7916); a total distance of approximately 230 metres.

##### **Footpath 72 Neen Savage**

The full width of Footpath 72 Neen Savage, from point C on the Order Map (GR SO 6837 7930) running in a general southerly direction to the rear of Bury Cottage and then to the rear of Little Overwood for approximately 140 metres to a boundary at point B on the Order Map (GR SO 6837 7916), then continuing in a general southerly followed by south-south-westerly direction across an arable field for a further 360 metres to point D on the Order Map (GR SO 6828 7882) where it meets the County Road (Baveney Lane); a total distance of approximately 500 metres.

##### **Footpath 75 Neen Savage**

The full width of Footpath 75 Neen Savagae, from point D on the Order Map (GR SO 6828 7882) where it leaves the County Road (Baveney Lane), running in a general westerly followed by south westerly direction over an arable field to point E on the Order Map (GR SO 6805 7882); a total distance of approximately 248 metres.
