a) New Planning Application:

- i) Reference: 23/04534/FUL (validated: 14/11/2023)

Address: The Old Vicarage, Neen Savage, Cleobury Mortimer, DY14 8JU

Proposal: Erection of a garage

Applicant: Mr Griffin.

Outcome: Council noted that this application has since been granted without amendments to the proposed doors which the Historic Environment Officer had recommended. It was further noted that the application for Listed Building Consent had been withdrawn as it was not required despite the proximity of the proposed garage to the main house which is a listed building. Shropshire Council's definition of curtilage for listed buildings will be clarified for any future applications. There has been some confusion regarding proposals to convert the piggery into residential accommodation in the applicant's Heritage Impact Statement yet this is not mentioned in other documents with this application.
