i) Clerk's Report

Environmental Maintenance Grant

The Grant Report for 25-26 has been submitted together with this year's application.

Action Log Review

Ford - No response to previous chasers regarding replacement safety railings, ditch and culvert work. Cllr Tomkinson will chase again. The new depth gauges at the Ford will be assessed for accuracy.

Land Registry – Due to incomplete information received from Land Registry, the Clerk will purchase the title details to establish what has been done by Land Registry following our applications.

Website – The website manager will be asked for the latest invoice. The website is functioning well but may need to have the software upgraded to be compliant with a “.gov.uk” domain.

Six Ashes – Cllr Tomkinson has planted oaks to replace the ash trees which had been removed. The planters by the car park will need watering in this hot dry weather.

Broadband to Parish Hall – the Clerk will keep chasing BT to upgrade the supply to fibre broadband.

Goesland barrier and road repairs – there has been no response from highways on dates for repairs.

Police – attended the Annual Parish Meeting and will be invited to future meetings if any local issues.

Highway issues generally – no response to emails but drain cover on Baveney Lane was replaced.

Pike Common – grass will be cut next month. There are ongoing concerns of trees and debris in river especially the amount of debris backing up at Papermills Bridge.

Welcome Packs – Cllr Del Mar has more Neen Savage books to be given out to new residents.

Online banking – councillor signatories need to get access to the accounts through business banking.

Land below Melbury – Shropshire Council has been asked to ensure the unauthorised caravan is removed and the land reinstated.

New Notice Board at Parish Hall car park entrance has been installed. The invoice is awaited.
